

## **M-Files Compliance Kit June 2023 Update Service Release 1 (23.6.1132.10) Release Notes**

M-Files Compliance Kit June 2023 Update and its service releases are compatible with M-Files Online February '23 Update and later.

Summary of the fixed issues and improvements in this release:

---

### **M-Files Compliance Kit June 2023 Update Service Release 1 (23.6.1132.10)**

**Improvement:** Multi-selection for Object Creator

**ID:** V-78789

**Description:** Rules for the Object Creator module can now be configured to be usable when multiple objects are selected in the listing area. This lets users create objects that reference all the selected objects.

**Defect:** Sequence ID generation cannot always be completed

**ID:** 167709

**Symptom:** Conflicts can cause that the generation of sequence IDs from rules specified in the Utilities module cannot be completed.

**Solution:** Fixed.

**Defect:** Resolution of related object properties can cause unnecessary server calls

**ID:** 167908

**Symptom:** Some operations for which it is necessary to resolve related objects and their metadata can cause unnecessary server calls, which can have a negative performance effect.

**Solution:** Fixed.

**Defect:** Version Control Lite documents cannot be copied or created with M-Files Importer

**ID:** 167944

**Symptom:** M-Files Importer cannot copy or create Version Control Lite documents that use number-based property definitions to store the version.

**Solution:** Fixed.

**Defect:** PDF processing causes an "invalid page range" error

**ID:** 168224

**Symptom:** The PDF Processor module cannot process some documents but instead shows an "invalid page range error" error.

**Solution:** Fixed.

**Defect:** Object Creator buttons slow to update after object selection

**ID:** 168186

**Symptom:** The buttons for the Object Creator module are shown after a long delay after an object is selected in the listing area.

**Solution:** Fixed.

**Defect:** PDF processing causes an "incorrect NamespaceURI" error

**ID:** 167600

**Symptom:** The PDF Processor or Controlled Printing module cannot process some PDF documents but instead shows an error similar to this one: "System.ArgumentException: The namespace declaration attribute has an incorrect 'namespaceURI': 'http://www.w3.org/2000/xmlns/'."

**Solution:** Fixed.

**Defect:** PDF processing causes a "not a legal OleAut date" error

**ID:** 167190

**Symptom:** The PDF Processor module cannot convert to PDF a DOCX file with charts but instead shows an error

similar to this one: "Not a legal OleAut date."

**Solution:** Fixed.

**Defect:** Excel documents with filling conditions not converted to PDF correctly

**ID:** 167489

**Symptom:** The PDF Processor module cannot correctly convert to PDF Excel documents that contain filling conditions.

**Solution:** Fixed.

**Defect:** Images in a Word document distorted after conversion to PDF

**ID:** 168015

**Symptom:** Images can become distorted after a conversion from DOCX to PDF.

**Solution:** Fixed.

**Defect:** Images can overlap after conversion from DOCX to PDF

**ID:** 168604

**Symptom:** The PDF Processor module can cause some images to overlap after a conversion from DOCX to PDF.

**Solution:** Fixed.

**Defect:** Some elements in Visio files not shown after PDF conversion

**ID:** 168466

**Symptom:** After some Visio files are converted with the PDF Processor module, some of the elements are not shown in the PDF.

**Solution:** Fixed.

**Defect:** Generated links do not operate correctly in M-Files Web or classic M-Files Web

**ID:** 167708

**Symptom:** When a vault's configured web address ends with a slash, links generated by Compliance Kit do not operate in M-Files Web and the classic M-Files Web.

**Solution:** Fixed.

### **M-Files Compliance Kit June 2023 Update (23.6.1132.1)**

**Improvement:** Logging support

**ID:** 167524

**Description:** M-Files Compliance Kit can now be set to log its behavior. This helps to better understand what it is doing, to troubleshoot interactions between modules, and for other applications and to analyze performance bottlenecks.

**Improvement:** Setting for reducing informational logging in Log Exporter

**ID:** 159940

**Description:** You can now set the Log Exporter module to not create Windows event log entries for specific events.

**Improvement:** TLS 1.2 support for Log Exporter

**ID:** 163451

**Description:** The Log Exporter module now uses TLS 1.2.

**Improvement:** Quicker access to vaults that use M-Files Compliance Kit

**ID:** 164053

**Description:** In M-Files Desktop and M-Files Web, it is now faster to open vaults that use M-Files Compliance Kit.

**Improvement:** Multi-object actions in Object Creator

**ID:** 155652

**Description:** You can now select many objects (for example, documents) and create a single object (for example, a document collection) with the Object Creator module.

**Improvement:** Extended language support for PDF Processor

**ID:** 164393

**Description:** You can now set the PDF Processor module to use extended language support if there are issues with the conversion of non-English Word files to PDF.

**Defect:** Object Creator buttons shown after a delay

**ID:** 167301

**Symptom:** When the user selects a Document object, the Object Creator buttons are shown after a delay.

**Solution:** Fixed.

**Defect:** Object creator buttons shown unnecessarily

**ID:** 167311

**Symptom:** When the user selects many documents, the Object Creator buttons are shown even if all the selected documents do not match the filtering requirements.

**Solution:** Fixed.

**Defect:** Utilities module does not create a new unique sequence

**ID:** 167038

**Symptom:** The Utilities module does not always create a new unique sequence. This can cause new documents to get an incorrect sequence number.

**Solution:** Fixed.

**Defect:** Calendar application causes slowness

**ID:** 162217

**Symptom:** The home screen view of M-Files Compliance Kit takes a lot longer to load when the Calendar application is enabled and set to show objects.

**Solution:** Fixed,

**Defect:** Upgrade Vault Structure operation can cause an unclear error message

**ID:** 160640

**Symptom:** The Upgrade Vault Structure operation cannot sometimes be completed. An unclear error message is shown instead.

**Solution:** Fixed.

**Defect:** Managed Properties cannot edit stub objects

**ID:** 161627

**Symptom:** The Managed Properties module cannot sometimes edit stub objects. This error message is shown instead: "The Managed Properties module was unable to edit the property value 'PD.xxx' of the object 'xx' (x-x-x). System.Runtime.InteropServices.COMException (0x80040001): Editing of special objects such as shortcuts and conflicts is restricted. You are not allowed to add, modify, or remove the property 'xxx'."

**Solution:** Fixed.

**Defect:** Managed Properties cannot sometimes update auto-calculated properties

**ID:** 163903

**Symptom:** The AutoCalculatedProperties functionality does not update the property if only the letter case is changed in metadata.

**Solution:** Fixed.

**Defect:** File version check in Log Exporter can cause an uninformative error message

**ID:** 163048

**Symptom:** If there is mismatch in file version data and the user tries to save a new version, the operation cannot sometimes be completed. This error message is shown instead: "The action was denied because the property 'File Version' was not updated correctly. To fix the issue, change event handler execution order."

**Solution:** Fixed.

**Defect:** Copy rules do not sometimes operate correctly with Object Creator

**ID:** 164077

**Symptom:** The "Allow copy (no command button)" copy rule of the Object Creator module does not always operate correctly. This error message is shown instead: "Copying the selected object is not allowed."

**Solution:** Fixed.

**Defect:** Deleted documents trigger state change notifications in Advanced Notifications

**ID:** 164248

**Symptom:** There is a notification rule set to send an email when the user moves a document to a specific state. If the user after this deletes the document, an email notification is sent incorrectly based on the notification rule associated with the workflow state.

**Solution:** Fixed.

**Defect:** Storage format upgrade of unique sequences not done with Compliance Kit December '21 Update

**ID:** 163822

**Symptom:** The storage format upgrade of unique sequences is not always done with Compliance Kit December '21 Update. This causes that the sequence values generated before the upgrade start from the beginning. New document creation can thus cause two documents to incorrectly have the same sequence number.

**Solution:** Fixed.

**Defect:** PDF Processor uses a lot of memory with Excel files

**ID:** 166850

**Symptom:** The PDF Processor uses a lot of memory on the M-Files server during Excel to PDF conversions.

**Solution:** Fixed.

**Defect:** M-Files Web home page links contain an extra slash

**ID:** 166018

**Symptom:** There is an extra slash at the end of the M-Files Web home page URL received from M-Files API. The slash character must not be in the URL even if the configuration of "M-Files Web home page" setting has a slash at the end.

**Solution:** Fixed.

**Defect:** Word to PDF conversion cannot be done for documents that use the track changes feature

**ID:** 164986

**Symptom:** The PDF Processor module cannot convert Word documents to PDF when the Word document uses the track changes feature.

**Solution:** Fixed.

**Defect:** PDF Processor sometimes converts graphs incorrectly

**ID:** 163303

**Symptom:** The PDF Processor module can sometimes cause graphs in a Word document to be converted incorrectly. For example, a label with values can disappear during the conversion.

**Solution:** Fixed.

**Defect:** PDF conversion can remove font color

**ID:** 166786

**Symptom:** Visio document to PDF conversions with the PDF Processor module can cause the font color for some of the texts to change.

**Solution:** Fixed.

**Defect:** QMS 8.0 documents cannot always be converted with PDF Processor

**ID:** 167228

**Symptom:** The PDF Processor module cannot always convert QMS 8.0 controlled documents.

**Solution:** Fixed.

**Defect:** Large error message about incomplete Compliance Kit upgrade in the Hierarchy Manager dashboard  
**ID:** 161743

**Symptom:** After a failed Compliance Kit upgrade, the Hierarchy Manager dashboard can show a long and obscure error message.

**Solution:** Fixed.

**Defect:** Objects not processed correctly by Hierarchy Manager

**ID:** 165999

**Symptom:** If, in a multi-select value list, there is an item that does not match the "Acceptable Sibling State Conditions" criteria configuration, the Hierarchy Manager module does not always use the criteria correctly for the rest of the value list items.

**Solution:** Fixed.
